



Alex Dall appointed as Gold Fields Chief Financial Officer

Johannesburg, 7 February 2025: The Board of Gold Fields is pleased to announce the appointment of Alex Dall as the permanent Chief Financial Officer (CFO) and an Executive Director of the Company effective from 1 March 2025

Mr Dall had been Interim Financial Officer ahead of the scheduled appointment of Phillip Murnane as CFO, announced on 26 August 2024. At the time of the August announcement, the Company stated that Mr Murnane's likely commencement date was expected to be in early 2025. Mr Murnane has communicated that, due to personal reasons, he is unfortunately unable to join the Company.

During the interim period, Mr Dall has demonstrated strong and visible leadership, strategic and financial acumen and a deep commitment to the success of the Company, making valuable contributions to the global business.

Prior to his appointment as Interim Financial Officer in April 2024, when the previous CFO Paul Schmidt retired, Mr Dall was Vice-President Corporate Finance for Gold Fields. He has been pivotal in structuring, negotiating, and executing group funding strategies, providing strategic oversight on M&A transactions, and driving corporate financial, tax and capital efficiency initiatives.

Mr Dall is a qualified Chartered Accountant having obtained his Bachelor of Business Science and Post Graduate Diploma from the University of Cape Town. He joined the Company in 2014, focusing on technical accounting work and was promoted to VP Corporate Finance in 2022. Prior to Gold Fields, he worked at KPMG, where he completed his articles in the energy and natural resources department.

Gold Fields Chief Executive Officer, Mike Fraser, said: "I would like to congratulate Alex on his well-deserved appointment. The leadership he has shown while in the interim CFO role give me confidence that he will be invaluable as we continue to improve our safety, operational and financial performance, strengthen our financial position and grow the Company."

Gold Fields Chairman Yunus Suleman said: "On behalf of the Board I would like congratulate Alex on his appointment and welcome him to the Board. With his deep understanding of the Gold Fields business and solid financial and strategic proficiency, I look forward to Alex's contributions in the role of CFO."
