**Johannesburg, 29 November 2022:** Gold Fields Limited (Gold Fields) (JSE, NYSE: GFI) has become aware of a scam that promotes financial investments through a fake app and WhatsApp group. It uses our company name, as well as photos of Gold Fields board members and/or executives.

We have no connection to this app or WhatsApp group whatsoever and strongly urge you not to download or transact on it. Gold Fields also cannot take responsibility for losses incurred as a result of using these fake apps or WhatsApp Groups.

Internationally cyberfraud schemes and fake apps are on the rise and designed to defraud investors.
